EDUCATION FUND (AOCEF) SCHEME**

1. Reference SAO 3/S/2003.
2. It has been decided to close the AOCEF scheme with effect from 01 Apr 2011. CDA(O) is being requested not to deduct AOCEF subscription from the salary of the officers wef the above date.
3. **Refund of Subscription.** All officers on the strength of the Army as on 31 Mar 2011 who have not drawn any benefit from the AOCEF scheme will be refunded their total subscription amount with 6 % interest. The above category of officers are requested to forward their particulars to **Director AOCEF, Building No 202, Shankar Vihar, Delhi Cantt, New Delhi-10** as per format attached by 28 Feb 2011 after which no application for refund of AOCEF subscription with interest will be accepted. The refund of subscription with interest will be paid wef 01 Apr 2011 through multicity cheques drawn on the names of the officers.
4. **One Time Education Grant/Old Rate Scholarships.** One Time Education Grant/old rate scholarship will be paid to following categories of officers provided their children have not completed 28 years of age before receipt of application in AOCEF. Eligible Army Officers who have not submitted particulars of their children to AOCEF as per format given at Appx 'A' to SAO 3/S/2003 are requested to submit the same by 31 Mar 2011 after which no application for One Time Education Grant / Old Rate Scholarships would be accepted.
  - (a) Officers who contribute subscription for 26 years upto 31 Mar 2011 as per existing procedure.
  - (b) Fatal battle/physical casualties upto 31 Mar 2011.
  - (c) Medically boarded out officers up to 31 Mar 2011.
  - (d) Officers who retire prematurely upto 31 Mar 2011 and deposit subscription in one lumpsum with AOCEF to complete 26 years of subscription before proceeding on retirement
